

**BYLAW 2026-01**

Rural Municipality of Lajord No. 128

**A BYLAW TO ESTABLISH FEES PAYABLE TO THE RURAL MUNICIPALITY OF LAJORD NO. 128 FOR MUNICIPAL SERVICES RENDERED UNDER THE AUTHORITY OF *THE MUNICIPALITIES ACT* AND THE BYLAWS OF THE RM.**

The Council of the Rural Municipality of Lajord No. 128 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the “Fees and Charges Bylaw.”
2. Schedule A will be the set fees and charges for ratepayers and non-ratepayers.
3. Any unpaid fees or charges owned to the RM by a ratepayer including any penalties related thereto as well as any fines imposed to the ratepayer by the court for contravention of the RM Bylaws may be added to the taxes of the said ratepayer and may be collected or enforced in the same manner as a tax as defined by *The Municipalities Act*.
4. This Bylaw shall come into force and effect on the passing of this Bylaw.
5. Bylaw 2024-01, shall hereby be repealed.
